Wag N Wash businesses provide self-service pet bathing, professional pet bathing services, and the retail sale of pet supplies, pet accessories, pet bakery items, and pet deli items ("WNW Business(es)").

The total investment necessary to begin operation of a WNW Business is between \$445,160 and \$635,235. This includes \$67,035 to \$74,235 that must be paid to the franchisor or its affiliate.
