Wag N Wash businesses provide self-service pet bathing, professional pet bathing services, and the retail sale of pet supplies, pet accessories, pet bakery items, and pet deli items (“WNW Business(es)”).

The total investment necessary to begin operation of a WNW Business is between \$525,305 and \$751,535. This includes \$67,035 to \$74,235 that must be paid to the franchisor or its affiliate. The total investment necessary to begin operation of a Multi-3 Franchise is between \$1,060,610 and \$2,264,605 depending on the number of WNW Businesses opened. This includes \$144,070 to \$192,705 that must be paid to the franchisor or its affiliate(s). The total investment necessary to begin operation of a Multi-5 Franchise is between \$2,091,220 and \$3,707,675 depending on the number of WNW Businesses opened. This includes \$258,140 to \$321,175 that must be paid to the franchisor or its affiliate(s).

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully.
