The franchisee will operate a "Walk-On's Bistreaux & Bar," which is a Louisiana themed sports grill offering a variety of fresh, cooked to order, menu items such as sandwiches, seafood, Southern Louisiana specialties, hamburgers and salads. We also offer qualifying franchisees the right to develop multiple Walk-On's Bistreaux & Bais under an Area Development Agreement.

The total investment necessary to begin operation of a single Walk-On's Bistreaux & Bar is from \$1 190,500 to \$2,358,000 (not including real property), including \$90,000 that must be paid to the franchisor or its affiliate. The total investment necessary to enter into an Area Development Agreement for the operation of multiple Walk-On's Bistreaux & Bars is from \$120,000 to \$180,000 (assuming, for the low end of the range, four Walk-On's Bistreaux & Bars and for the high end of the range, six Walk-On's Bistreaux & Bars, although, this is neither a minimum or a maximum), including \$120,000 to \$180,000 that must be paid to the franchisor or its affiliate

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English Read this disclosure document and all accompanying agreements carefully You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale Note, however, that no government agency has verified the information contained in this document
