Wanna Play Playcare franchisees provide parents with a safe, reliable drop in child care experience, as well as flexible preschool, after-school care and camp options.

The total investment necessary to begin operation of a Wanna Play Playcare Single Unit franchised business is \$220,550 to \$323,650. This includes a Franchise Fee of either \$19,750.00, \$28,750.00, or \$39,750.00 to secure your chosen territory. This includes \$20,750 - \$40,750 that must be paid to Us.
