The franchise described is known as “Wanna Play Playcare”™. Wanna Play Playcare is involved in the business of providing flexible childcare solutions for children ages 6 weeks to 12 years. Wanna Play Playcare Centers provide parents with on-demand hourly drop-in child care, as well as a play based-preschool, and optional after school pick-up, camps, full-time care, private parties and planned events. The Centers offer extended hours on weekdays and weekends with a schedule that includes age appropriate, teacher guided activities as well as child led open-ended play.

The total investment necessary to begin operation of a Wanna Play Playcare Single Unit franchised business is \$289,116 to \$449,300. This includes \$25,900 to \$40,900 that must be paid to us or an approved supplier.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note however, that no governmental agency has verified the information contained in this document.**
