WaterWalk Franchise Services LLC ("WWFS") will grant an approved franchisee a franchise license from WWFS to operate an Oakwood WaterWalk Property ("Property"), which offers customers unfurnished and furnished lodging options with hotel-like services.

The total investment necessary to begin operation of an Oakwood WaterWalk Property ranges from \$19,965,000 to \$25,470,000. This includes the initial fees owed to WWFS varying from between \$117,000 and \$627,500 that must be paid to WWFS or its affiliates when the Property has no more than 153 units. If the Property will have more than 153 units, the payment to WWFS and its affiliates and the total investment is increased by \$375 per each additional unit.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

- 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY MEDIATION AND/OR LITIGATION ONLY IN KANSAS. OUT-OF STATE MEDIATION AND/OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO MEDIATE AND/OR LITIGATE WITH US IN KANSAS THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT KANSAS LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. OAKWOOD PM LLC IS THE ONLY MANAGEMENT COMPANY AT THIS TIME APPROVED TO MANAGE FRANCHISE PROPERTIES. UNDER THE PROPERTY MANAGEMENT AGREEMENT YOU MUST PAY \$7,500 PER MONTH BEGINNING 4 MONTHS BEFORE YOU OPEN.
- 4. THE FRANCHISEE WILL BE REQUIRED TO MAKE AN ESTIMATED INITIAL INVESTMENT RANGING FROM \$19,960,000 TO \$25,430,000. THIS AMOUNT EXCEEDS THE FRANCHISOR'S GUARANTOR'S MEMBER CAPITAL AS OF DECEMBER 31, 2018, WHICH IS \$206,375.
- 5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We may use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
