<u>Single Gym Program</u> Under this program, you will sign a Franchise Agreement to operate one WRTS Kid's Gym The total investment necessary to begin operation of a WRTS Kid's Gym ranges from approximately \$109,525 to \$128,225 This includes \$51,525 that must be paid to us or our affiliate

<u>Area Development Program</u> Under this program, we will assign you a defined area within which you must develop and operate a minimum of 2 WRTS Kid's Gyms within a specified period of time. The total investment necessary to begin operation of 2 WRTS Kid's Gyms ranges from approximately \$130,525 to \$152,225. This includes \$71,525 that must be paid to us or our affiliate.

<u>We Rock on Wheels Program</u> Under this program, you will sign a Franchise Agreement to operate one mobile WRTS Kid's Gym The total investment necessary to begin operation of a mobile WRTS Kid's Gym ranges from approximately \$72,000 to \$88,750 This includes \$67,500 to \$80,750 that must be paid to us or our affiliate
