The franchise offered is for the right to operate a business maintaining quality turf for residences and businesses by providing various professional services under the trademarked name "WEED MAN".

The total investment necessary to begin operation of a WEED MAN franchise is \$67,043 to \$84,103. This includes \$20,000 to \$33,750 that must be paid to Turf Holdings Inc.
