The franchisee will operate one or more Weichert Offices providing residential real estate brokerage services and, if the franchisee wishes, non-residential real estate brokerage services.

The total investment necessary to begin operation of a Weichert franchise is from \$50,000 to \$364,700, excluding real property, including \$25,000 that must be paid to the franchisor with an additional \$12,500 per office for each Additional Office to be opened.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

THE FRANCHISE AGREEMENT REQUIRES YOU TO ARBITRATE CERTAIN DISPUTES WITH US ONLY IN THE STATE AND COUNTY IN WHICH OUR PRINCIPAL PLACE OF BUSINESS IS LOCATED AT THE TIME THE ARBITRATION PROCEEDING IS COMMENCED AND RESOLVE OTHER DISPUTES WITH US BY LITIGATION ONLY, EITHER IN A NEW JERSEY STATE COURT IN MORRISTOWN, NEW JERSEY OR THE UNITED STATES DISTRICT COURT FOR THE DISTRICT OF NEW JERSEY IN NEWARK, NEW JERSEY. WE CAN BRING SUIT FOR THOSE DISPUTES AT ANY COURT WE SELECT. OUT OF STATE ARBITRATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO ARBITRATE WITH US IN THE STATE AND COUNTY IN WHICH OUR PRINCIPAL PLACE OF BUSINESS IS THEN LOCATED OR SUE US IN NEW JERSEY OR ANOTHER STATE'S COURT WE SELECT THAN IN YOUR HOME STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT ALL MATTERS RELATING TO ARBITRATION OR THE ENFORCEMENT OF THIS AGREEMENT TO ARBITRATE WILL BE GOVERNED BY THE FEDERAL ARBITRATION ACT AND THAT OTHERWISE NEW JERSEY LAW GOVERNS THE AGREEMENT. THESE LAWS MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. FAILURE TO MEET ANNUAL MINIMUM PERFORMANCE REQUIREMENTS MAY RESULT IN THE LOSS OF YOUR TERRITORIAL EXCLUSIVITY.
- 4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
