The franchised business is the operation of one or more bakeries specializing in hand-rolled soft fresh-baked pretzels. We offer 2 franchise programs:

1. A single WETZEL'S PRETZELS® Bakery. The total investment necessary to begin operation of a WETZEL'S PRETZELS® Bakery ranges from ~~\$156,300~~ \$156,550 to ~~\$370,950~~ \$370,900. This includes approximately \$38,100 that must be paid to the franchisor. If Wetzel's Pretzels grants you a license to operate a Remote Mobile Unit under a Remote Mobile Unit Addendum to your Franchise Agreement, you will also pay it a fee of \$5,000 for a Remote Mobile Unit.

2. Multiple WETZEL'S PRETZELS® Bakeries within a defined area pursuant to a Multi-Unit Development Agreement. There is an initial development fee of \$10,000 multiplied by the number of Bakeries (excluding the first Bakery) which you must open, plus \$35,000 representing the initial franchise fee for your first Franchise Agreement. You will pay an initial franchise fee of \$35,000 for each Bakery (\$22,500 for a second Bakery in the same mall). However, we will credit the development fee against the initial franchise fees (at the rate of \$10,000 for the second and each subsequent Franchise Agreement).

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payments to, the franchisor or an affiliate in connection with the proposed franchise sale or grant. **Note, however, that no governmental agency has verified the information contained in this document.**
