You will operate a retail business that offers more than 50 varieties of customizable "wiches," as well as salads, milkshakes, soft drinks, chips, cookies, and related items under the WHICH WICH® trade name and business system ("WHICH WICH® Store" or "Store").

Currently, it is our policy to award only multi-unit development rights; franchisees who are new to the system must commit to develop at least two Stores according to the terms of our development agreement. The total investment necessary to develop two WHICH WICH® Stores under the development agreement ranges from \$195,000 to \$488,750. This includes the \$48,250 to \$52,750 that must be paid to us or our affiliate. If you acquire the right to develop five Stores and purchase limited territory protection, your total investment ranges from \$282,500 to \$576,250, which includes the \$135,750 to \$140,250 that must be paid to us or our affiliate. If you are an existing franchisee, and if you qualify, you may open other Stores, one at a time. Under these circumstances, the total investment necessary to develop an additional WHICH WICH® Store ranges from \$172,000 to \$473,250. This includes the \$25,250 to \$37,250 that must be paid to us or our affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

THE FRANCHISE AGREEMENT AND DEVELOPMENT AGREEMENT REQUIRE YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION IN THE THEN-CURRENT CITY OF OUR PRINCIPAL BUSINESS OFFICE, WHICH IS CURRENTLY DALLAS, TEXAS. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN A STATE OTHER THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT AND DEVELOPMENT AGREEMENT STATE THAT TEXAS LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
