The franchise offered is for a business providing specialty food production and distribution of fresh and healthy foods for children to partner schools and other educational facilities under the names “Wholesome Tummies” and “WT Cafe”. A Wholesome Tummies/WT Café business operates using the franchisor’s proprietary recipes, formulae, techniques, trade dress, trademarks and logos. We also offer a separate franchise for Captive Market locations, as described in Item 1.

The total investment necessary to begin operation of a Wholesome Tummies/WT Café franchise is \$66,900 to \$186,000, or \$45,500 to \$263,200 for a Captive Market franchise. This includes between \$42,500 to \$46,000 that must be paid to the franchisor and/or its affiliate, as appropriate for a Wholesome Tummies/WT Café franchise, or \$7,500 to \$17,500 to the franchisor and/or its affiliate, as appropriate for a Captive Market franchise.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
