UNIFORM FRANCHISE DISCLOSURE DOCUMENT

Franchisor is offering franchises for the operation of a fast food business featuring "buffalo" style chicken wings. The initial franchise fee is \$15,000 for a single unit franchise. The total estimated initial investment ranges from \$76,000 to \$162,000 for a single unit franchise which includes \$15,000 payable to the franchisor or its affiliates. We also award to qualified persons, under our Master Developer Agreement, the right to solicit prospective franchisees and to provide on-going support to franchisees located in a particular geographic area. When a Master Developer Agreement is signed, the Master Developer must pay (i) \$100,000 for a Territory that includes up to 2,000,000 people, or (ii) \$125,000 for a Territory with a population of between 2,000,000 and 3,000,000 people. Territories containing more than 3,000,000 people will be assessed on a case-by-case basis according to population and demographics. The estimated initial investment required to establish a master developer territory ranges from approximately \$144,500 to \$198,000. The initial investment estimate is only approximate and initial fees are more fully described in Items 5, 6, and 7 of this Disclosure Document.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read your entire contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant. Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind. More information on franchising, such as "A Consumer's Guide to Buying a Franchise," which can help you understand how to use this disclosure document, is available from the Federal Trade Commission. - 1. THE FRANCHISE AGREEMENT AND MASTER DEVELOPER AGREEMENT REQUIRE YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION ONLY IN COLORADO. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN COLORADO THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT AND MASTER DEVELOPER AGREEMENT STATE THAT COLORADO LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS
