A **WING ZONE**[®] franchise is a dine-in and take-out restaurant serving chicken wings, chicken tenders, sandwiches, appetizers, related food products, beverage products, and ancillary merchandise under the name "**WING ZONE**."

The total investment necessary to begin operation of a single WING ZONE franchise is \$262,650 to \$387,650. This includes \$27,500 to \$37,500 that must be paid to the franchisor or an affiliate. If you sign an Area Development Agreement, you will pay a Development Fee equal to \$10,000 multiplied by the number of restaurants you agree to develop.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.
