A WING ZONE[®] franchise is a dine-in, delivery and carry-out restaurant serving chicken wings, chicken tenders, sandwiches, appetizers, related food products, beverage products, and ancillary merchandise under the name "WING ZONE."

The total investment necessary to begin operation of a single WING ZONE franchise is \$238,500 to \$391,405. This includes \$35,000 to \$40,000 that must be paid to the franchisor or an affiliate. If you sign an Area Development Agreement, you will pay a Development Fee equal to \$10,000 multiplied by the number of restaurants you agree to develop (generally, you must develop a minimum of 5 restaurants but we have the right to adjust this general minimum requirement).

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on the Disclosure Document alone to understand your contract. Read all of your contract carefully. Show your contract and this Disclosure Document to an advisor, like a lawyer or an accountant.

- 1. THE FRANCHISE AGREEMENT AND THE AREA DEVELOPMENT AGREEMENT REQUIRE YOU TO RESOLVE DISPUTES WITH US BY MEDIATION, ARBITRATION OR LITIGATION ONLY IN GEORGIA. OUT-OF-STATE MEDIATION, ARBITRATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO MEDIATE, ARBITRATE OR LITIGATE WITH US IN GEORGIA THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT GEORGIA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

YOUR SPOUSE MUST SIGN A DOCUMENT THAT MAKES YOUR SPOUSE LIABLE FOR ALL YOUR FINANCIAL OBLIGATIONS UNDER THE FRANCHISE AGREEMENT EVEN THOUGH YOUR SPOUSE HAS NO OWNERSHIP INTEREST IN THE FRANCHISE. THIS GUARANTEE WILL PLACE BOTH YOU AND YOUR SPOUSE'S MARITAL AND PERSONAL ASSETS, PERHAPS INCLUDING YOUR HOUSE, AT RISK IF YOUR FRANCHISE FAILS.
- 4. FAILURE TO MEET THE DEVELOPMENT SCHEDULE UNDER THE AREA DEVELOPMENT AGREEMENT MAY RESULT IN THE TERMINATION OF THE AREA DEVELOPMENT AGREEMENT.
- 5. THERE MAY BE OTHER RISK FACTORS CONCERNING THIS FRANCHISE.
