The franchisee will operate a Wingate by Wyndham[®] guest lodging facility franchise offering overnight accommodations and related services.

The total investment necessary to begin operation of a Wingate by Wyndham franchise for a 100 room new construction facility ranges from \$6,147,170 to \$8,201,100. The above amounts include from \$43,900 to \$46,400 that must be paid to the franchisor or an affiliate.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
