WINGS ETC.® restaurants will have a family-oriented sports theme and will offer a wide variety of chicken wings, barbecued ribs, sandwiches, burgers and other products (for on-premises dining and carry-out) and beverages including beer, wine and liquor. We sell franchises for the right to operate a single WINGS ETC. restaurant.

The total initial investment necessary to begin operations of a WINGS ETC. restaurant franchise ranges from \$248,650 to \$751,200. This amount includes an Initial Franchise Fee of \$29,500, which must be paid to us.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
