Asqualified individuals and entities a World Gym franchisee, you willfranchise for the right to independently own and operate a fitness facilityGym providing fitness training and equipment, related services and sale of nutritional items, exercise apparel and accessories; (each, a "Gym") utilizing our then-current proprietary marks, including our current primary mark WORLD GYM (collectively, the "Proprietary Marks") and the system of business operations developed by us (the "System"). We also offer qualified parties the right to develop multiple Gyms within a given geographical area we designate and in accordance with an agreed-upon and mandatory development schedule.

The <u>initialtotal</u> investment necessary to begin operation of <u>one new Worlda single</u> Gym <u>Facility</u> ranges from \$461852,000 to \$2,070975,000.

The initial investment necessary to convert one typical existing facility to a Facility ranges from \$29,500 to \$312,500.

These amounts include an initial franchise fee of \$35,000 (\$17,500 if you convert an existing fitness facility)—This includes \$45,000 that must be paid to the franchisor—us or its affiliate(s). These amounts also include a range of \$3,500 to \$5,000 in reimbursement to us for training and certification fees if you elect to participate in the World Gym Athletics programour affiliates.

We may sell rights to qualified individuals or entities to develop. The total investment necessary to operate multiple franchised facilities in a single, exclusive development territory. A multi-unit developer pays a development fee equal to \$17,500 multiplied by the total number of facilities the developer commits to developing Gyms under theour form of area development agreement, depends on the number of franchises we grant you the right to open. The total investment necessary varies based on the number of facilities to be developed.



If you sign an areaenter into a development agreement for the right to develop between three and five Facilities, your total initial investment for a single Facility (as noted above) will increase between

\$35(3) franchised Gyms is \$927,000 to \$3,035,000 (for a three unit deal) and \$70, which includes (i) the development fee amounting to \$120,000 (for a five unit deal). These that is paid to us prior to opening, and (ii) the estimated costs do not include the cost of establishing each of the subsequent Facilities to be opened under the area development agreement.

For example, if the developer signs an area development agreement to develop and open three to Gym Facilities, the developer's total investment necessary initial investment to begin operation of its first World Gym Facility, your initial Gym. The development fee is based on the number of franchised Gyms we award you the right to develop and is calculated as the sum of the following: (i) \$45,000 for the right to develop your initial Gym; plus (ii) \$40,000 for the right to develop a second Gym; plus (iii) \$35,000 for the area development fee, ranges from right to develop the third and each additional Gym. \$496,000 to \$2,139,500.
