As a franchisee, you will operate a gourmet lemonade stand under the name "Wow Wow Hawaiian Lemonades®."

The total investment necessary to begin operation of a Wow Wow franchised business is between \$137,500 and \$184,500. This includes \$30,000 that must be paid to the franchisor. The total investment necessary to begin operation of a Wow Wow Multi-Unit business is between \$142,500 and \$189,500. This includes \$35,000 that must be paid to the franchisor. The minimum number of units that must be opened under a Multi-Unit Agreement is 2.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
