

Signature high-energy 50 minute class formats at an intense pace with a focus on individual attention, strengthening, lengthening and fat burn, help clients achieve their best bodies. WundaBar Pilates studios may provide other services, such as retail sales of fitness apparel and other fitness related items

The total investment necessary to begin operation of a WundaBar Pilates studio is from \$150,100 00 to \$354,350.00 This includes the \$35,000.00 franchise fee that must be paid to the franchisor or affiliate. If under the terms of your Franchise Agreement you are granted the right to open more than one studio, then

the franchise fee for your second and subsequent studios is \$20,000 each. If your Franchise Agreement grants you the right to open only one studio, but after that first studio is open and operating you are subsequently granted the right to open additional studios the franchise fee for subsequent additional studios shall be 75% of the franchise fee for a new single-studio franchise at that time that you are granted the right to open additional studios
