The Xist Fitness Franchisee will operate an upscale health and fitness center featuring exercise equipment, personal training, fitness classes and related goods and services, together with limited tanning, massage and red light therapy services and related goods and services under the Marks.

The total investment necessary to being operation of an Xist Fitness Center is from \$694,100 to \$1,949,750. This includes the \$25,000 that must be paid to the franchisor or its affiliates. If you are signing an Area Development Agreement, the total investment necessary to begin your development operations ranges from \$69,000 to \$95,000. This includes \$60,000 that must be paid to the franchisor or its affiliates for the first 3 Centers you are required to open under the Area Development Agreement.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
