YoBlendz International, LLC ("YBL") offers franchises for the operation of self-serve yogurt stores (each, called a "Store") selling frozen yogurt, toppings, and other products and services approved by YBL. The Stores will operate from a designated location and within a designated territory under the mark YoBlendz[™]. The total investment necessary to begin operation of your first YoBlendz franchise ranges from \$109,500 to \$448,000. This includes \$57,000 that must be paid to YBL.

If you enter into a Development Agreement, at the time you execute the Development Agreement, you must pay YBL the entire initial franchise fee for your first Store (\$40,000) and a \$20,000 down payment for each additional Store which you are entitled to open under the Development Agreement. Before you develop each additional Store you will be required to execute additional Franchise Agreements for each Store and pay the then-current initial franchise fee. The \$20,000 paid for each additional Store under the Development Agreement will be applied towards the franchise fee due when each additional Franchise Agreement is executed. In addition, at your option and subject to the availability of our personnel, we may enter into a Services Agreement with you and charge you a fee ranging from \$69,500 to \$408,000 (payable in full at the time you enter the Services Agreement) in consideration of our performance of certain construction services for your franchise.

This Disclosure Document summarizes certain provisions of your Franchise Agreement, Development Agreement, and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the Information contained In this document.

The terms of your contract will govern your franchise relationship. Don't rely on the Disclosure Document alone to understand your contract. Read all of your contract carefully. Show your contract and this Disclosure Document to an advisor, like a lawyer or an accountant.
