Yoblendz International, LLC (the "Company") is a Florida limited liability company with its principal business address at 2893 Executive Park Drive, Suite 202, Weston, FL 33331. The Company's telephone number is (954) 217-3014.

The Company offers the franchise (the "Franchise") pursuant to a standard form franchise agreement (the "Franchise Agreement") to own and operate retail stores under the name "Yoblendz" offering to the public self-serve frozen yogurt flavors and a wide variety of fruit and candy toppings for on-premise consumption or carry-out (the "Store").

The initial franchise fee for a Store is \$40,000 plus a \$20,000 down payment for each additional Store that you are entitled to open under the Development Agreement. The estimated initial investment required per Store, including the initial franchise fee, is estimated to be between \$69,500 and \$408,000 depending, in part, on real estate costs and location of the Store.

The effective date of this offering circular is May 20th, 2011.

THIS OFFERING PROSPECTUS IS PROVIDED FOR YOUR OWN PROTECTION AND CONTAINS A SUMMARY ONLY OF CERTAIN MATERIAL PROVISIONS OF THE FRANCHISE AGREEMENT. THIS OFFERING CIRCULAR AND ALL CONTRACTS OR AGREEMENTS SHOULD BE READ CAREFULLY IN THEIR ENTIRETY FOR AN UNDERSTANDING OF ALL RIGHTS AND OBLIGATIONS OF BOTH THE FRANCHISOR AND THE FRANCHISEE.

THE FRANCHISE AGREEMENT PERMITS THE FRANCHISEE (TO SUE) (TO ARBITRATE WITH) YOBLENDZ INTERNATIONAL, LLC ONLY IN FLORIDA. OUT OF STATE (ARBITRATION) (LITIGATION) MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE (TO SUE) (TO ARBITRATE WITH) YOBLENDZ INTERNATIONAL, LLC IN FLORIDA THAN IN YOUR HOME STATE.
