The franchisor is offering a franchise license for the operation of a store offering frozen yogurt, frozen desserts, toppings of fresh fruit, candy, cereals, nuts and syrups in a self serve format under the name of "Yogli Mogli" Frozen Yogurt.

The total investment necessary to begin operation of a Yogli Mogli Frozen Yogurt is between \$297,500 to \$374,000. This includes \$35,000 that must be paid to the franchisor or its affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
