You will operate either a Yoo Collection hotel or a Yoo2 hotel, Yoo Collection hotels being an upscale brand and Yoo2 hotels a mid-market lifestyle brand under a Franchise Agreement with us.

The total investment to begin operation of a Yoo Collection hotel franchise is between \$17,150,650 and \$60,475,900, excluding real estate costs. This includes the amount of between \$810,000-\$2,310,000 that must be paid to us or our Group Companies.

The total investment to begin operation of a Yoo2 hotel franchise is between \$11,275,450 and \$20,285,800, excluding real estate costs. This includes the amount of \$475,000 - \$725,000 that must be paid to us or our Group Companies.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with us, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind. 1. THIS FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION ONLY IN WASHINGTON, DC . OUT OF STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO HOLD AN ARBITRATION IN WASHINGTON, DC THAN IN YOUR HOME STATE.

4. YOU WILL NOT RECEIVE AN EXCLUSIVE TERRITORY. YOU MAY FACE COMPETITION FROM OTHER FRANCHISEES, FROM OUTLETS THAT WE OWN, OR FROM OTHER CHANNELS OF DISTRIBUTION OR COMPETITIVE BRANDS THAT WE CONTROL.
5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
