Yummy Cupcakes, Inc sells franchises for upscale retail bakeshops that offer gourmet fresh-baked cupcakes and cupcake specialty products together with clothing, accessories, novelty items and promotional merchandise and related products and services under the trade name "Yummy Cupcakes" We offer 3 franchise programs

<u>Single Bakeshop Program</u> Under this program, you will sign a Franchise Agreement to operate one Yummy Cupcakes Bakeshop with an on-site baking facility. The total investment necessary to begin operations of a single Yummy Cupcakes Bakeshop ranges from \$129,727 to \$192,045, which includes \$55,756 to \$62,204 that must be paid to us or an affiliate

Area Development Program Under this program, you will sign an Area Development Agreement under which we will assign you a defined area within which you must develop and operate a specified number of Yummy Cupcakes Bakeshops with on-site baking facilities, within a specified period of time. The total investment necessary to begin operations of 2 - 3 Yummy Cupcakes Bakeshops under an Area Development Agreement ranges from \$248243,533 to \$506491,675. This includes \$116111,511 to \$190175,416 that must be paid to us or an affiliate. We will credit the initial development fee for your second and third Yummy Cupcakes Bakeshops against the initial franchise fees for your second and third Bakeshops (not to exceed a credit of \$5,000 for any one Franchise Agreement)

Satellite Development Program Under this program, you will sign an Area Development Agreement and Hub Bakeshop Addendum to Area Development Agreement under which we will assign you a defined area within which you must develop and operate a Hub Bakeshop with an on-site baking facility and specified number of Yummy Cupcakes Satellite Retail Stores without on-site baking facilities, within a specified period of time You will prepare Yummy Cupcakes products at your Hub Bakeshop for sale at the Hub Bakeshop and at your Satellite Retail Stores. The total investment necessary to begin operations of a Hub Bakeshop and 2 - 3 Yummy Cupcakes Satellite Retail Stores ranges from \$270258,235 to \$453424,587. This includes \$10189,384 to \$143114,530 that must be paid to us or an affiliate. We will credit the initial development fee for your second and third Satellite Retail Stores against the initial franchise fees for your second and third Satellite Retail Stores (not to exceed a credit of \$3,000 for any one Franchise Agreement)
