As a master franchisee you will operate a business under the Marks and System that will (i) market and sell franchises to Subfranchisees which will provide quality cleaning services to the general public on commercial premises within the Development Area; (ii) train and assist Subfranchisees to open and operate Subfranchise Businesses in the Development Area; (iii) obtain Customer Accounts for your Subfranchisees; (iv) provide billing and collection services to your Subfranchisees; and (v) operate a Cleaning Business within a Development Area.

The total investment necessary to begin operation of your Master Franchise Business is \$145,700 to \$320,500. This includes between \$50,000 and \$150,000 that must be paid to the franchisor or its affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

- 3. THE FRANCHISE OWNERS AND THEIR SPOUSES MUST EACH SIGN PERSONAL GUARANTIES MAKING EACH SPOUSE JOINTLY AND SEVERALLY LIABLE FOR ALL OBLIGATIONS OF THE FRANCHISE. THESE GUARANTIES PLACE EACH FRANCHISE OWNER'S AND EACH SPOUSE'S PERSONAL ASSETS AT RISK.**
- 4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.**

We may use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
